## Application Requirements

- The following documentation must be submitted with this application (do NOT submit original documents):**
- Proof of at least 3 months consecutive, current Washington State residency. The following documents are acceptable as proof of residency:
    - Accepted at all locations that sell the pass:**
      - Current, valid Washington State driver license or identification card.
    - Accepted at headquarters only:**
      - Current, valid Washington State Voter Registration card.
      - Washington State senior citizen property tax exemption.
  - Proof of age must be 62 year or older. The following documents are acceptable as proof of age:
    - Current, valid Washington State driver license or identification card.

**In-person purchase with application at headquarters, region office, and participating Washington State parks\* or by mail\*\*.**  
(Do not send cash by mail, check only)

**\*\*Do not mail applications prior to September 1. If an application and payment is received prior to September 1, the application and payment will be mailed back to applicant.**

- Pass Rules**
- Do not alter or make copies of your pass. Never share your pass or pass number with others.
  - Pass holders will be charged \$15 to replace lost, stolen or damaged passes.
  - The pass cannot be used with any other pass or discount.
  - The pass holder must cancel reservations if unable to use them.
  - The pass holder must be camping overnight and present at the site for entire length of stay to receive a discount.
  - The pass is only valid for the person it is issued to. The pass must be valid, and you must have it with you during your visit. Be prepared to show your pass and photo ID.
  - All camping discounts and associated benefits are limited to the site the pass holder is camping. Discounts and reduced fees are limited to 1 campsite or moorage site per night.
  - Do not make duplicate or multiple reservations for the same night. Including double sites.
  - Camping is limited to 10 consecutive nights at any single park from April 1 through September 30, and 20 consecutive nights October 1 through March 31.
  - Moorage is limited to three consecutive nights at any single park.
  - Pass holders are expected to treat park staff with respect and to follow park rules and staff guidance.
  - Current Off-Season pass may not be used to book reservation for next off season.

**Violation of discount pass or park rules will be subject to pass suspension, ineligibility to pass program or charged fees.**
